*"And hasten to forgiveness from your God and to a paradise whose breadth as the sky and the earth is reserved for those who fear Allah, (Ali 'Imran: 3: 133)*

*"so that He may admit the believing men and women into gardens beneath which rivers flow, they will abide therein and that He may cover their sins. And that is a great fortune in the sight of Allah (Al Fath : 48: 5)*

In an effort to open the veil of Allah's secret about how to prove paradise empirically, the author uses deoxyribonucleic acid as the basis.

## HYPOTHESES
