Umayyad dynasty in Andalus (300 H-422 H, 912 AD-1031 AD), the Ottoman dynasty in Turkey (699 H-1341H,1385M-1923M) has been established, but, in reality , the Islamic Caliphate and Dynasties, did not follow the first Islamic State established by the Prophet Muhammad saw in Medina in 1 H or 622 AD.
