HYPOTHESIS

Based on Deoxyribonucleic acid (DNA) humans are composed of 32.20% carbon atoms, 25.43% nitrogen atoms, 6.78% oxygen atoms and 35.59% hydrogen atoms. Where carbon, nitrogen, oxygen and hydrogen atoms are widely available around us and in the atmosphere.
