"O you who believe, obey Allah and obey the Messenger and ulil amri among you. Then if you differ in opinion about something, then return it to Allah and the Messenger, if you really believe in Allah and the Last Day. That is that is more important and the result is better (An Nisaa ': 4: 59)

In an effort to open the veil of Allah's secret about why Muslims in the world, allow Islamic law to be read only in the Quran, the author uses the basis of deoxyribonucleic acid.

HYPOTHESIS

Based on human Deoxyribonucleic acid (DNA), it consists of 32.20% carbon atoms, 25.43% nitrogen atoms, 6.78% oxygen atoms and 35.59% hydrogen atoms. Where carbon, nitrogen, oxygen and hydrogen atoms are widely available around us and in the atmosphere.
