In my attempt to unmask the Indonesian Muslims, they are still being confined in the cage of Pancasila secular law made by secularists Soekarno cs, based on deoxyribonucleic acid or deoxyribonucleic acid or the molecular structure of nucleic acids.

HYPOTHESIS
