ABSTRACT

First of all, by asking forgiveness from Allah SWT, here I try to reveal the signs of Allah SWT's greatness regarding marriage with two, three, four wives which is difficult to carry out because it leads to cruel acts based on the molecular structure of nucleic acid or deoxyribonucleic acid (DNA).

In the Qur'an, one verse is found which is the key to unlocking the secret of marriage with two, three, four wives which is difficult to implement because it leads to cruel acts, namely the verses:

"... then marry women (other) that you like: two, three or four. Then if you are afraid that you will not be able to do justice, then (marry) only one,... That is closer do not do cruel act (An Nisaa': 4: 3)

In an effort to open the veil of marriage with two, three, four wives which is difficult to carry out because it leads to cruel acts, the author bases on deoxyribonucleic acid or deoxyribonucleic acid or the molecular structure of nucleic acids.

HYPOTHESIS

Here I propose the hypothesis that polygamous marriages are difficult to carry out because they lead to cruel acts seen from Deoxyribonucleic acid (DNA).

DEOXYRIBONUCLEIC ACID (DNA)

DNA is a repository of genetic information that has a double structure that forms a double helix and which contains polynucleotide macromolecules that are arranged repeatedly from nucleotide polymers. This nucleotide is composed of folate, a 5 carbon sugar and one of the nitrogenous bases. The nitrogenous bases are Guanine (G), Adenine (A), Cytocine (C) and Thymine (T). Guanine (G) is composed of 5 carbon atoms, 5 nitrogen atoms, 1 oxygen atom and 5 hydrogen atoms.

Adenine(A) has 5 carbon atoms, 5 nitrogen atoms and 5 hydrogen atoms. Cytocine (C) contains 4 carbon atoms, 3 nitrogen atoms, 1 oxygen atom and 5 hydrogen atoms. Thymine (T) contains 5 carbon atoms, 2 nitrogen atoms, 2 oxygen atoms and 6 hydrogen atoms. Folate contains 1 phosphorus atom, 4 oxygen atoms and 2 hydrogen atoms. The 5 carbon sugar has 5 carbon atoms, 2 oxygen atoms and 8 hydrogen atoms.
