"...Indeed a mosque that was founded on the basis of piety (Quba mosque), from the first day onwards is more worthy for you to pray in it..." (At-Taubah, 108).

In an effort to open the veil about developing humans, who believe in Islam, inside the system or outside the system based on deoxyribonucleic acid or deoxyribonucleic acid or the molecular structure of nucleic acids.

HYPOTHESIS

Here I propose the hypothesis of developing humans, who believe in Islam, outside the system, which has been exemplified by the Prophet Muhammad based on Deoxyribonucleic acid (DNA).

DEOXYRIBONUCLEIC ACID (DNA)

1 phosphorus atom, 4 oxygen atoms and 2 hydrogen atoms. The 5 carbon sugar has 5 carbon atoms, 2 oxygen atoms and 8 hydrogen atoms.
