Or like the Jews think Yahweh is holy, humans must not study Yahweh, humans must not prove Yahweh, humans must not pollute the holy Yahweh. Humans must not say the word Yahweh, but must pronounce it as Adonai. Human hands are not allowed to touch the writings in the holy books, but must use a pointing stick. That's all, because Yahweh is holy, no pollution should come from humans.

So, what the Jews consider about Yahweh, is accepted by most Islamic scholars in the world including Abu Hanifah, Malik bin Anas, Syafi'i and Ahmad bin Hambal, until now.

Well, this is the result of most Islamic scholars in the world including Abu Hanifah, Malik bin Anas, Syafi'i and Ahmad bin Hambal did not understand the real Allah through Allah's form in the form of Allah's spirit, Allah's energy and Allah's particle.
