"And Maryam, the daughter of Imran, who kept her honor, so We breathed into her a part of Our spirit, and an explanation of her Lord and His Books, and she was one of the obedient ones. (At Tahrir: 66:12)

"So when I have perfected its implementation, and it has been implemented into my spirit, then submit to it prostrating (Al Hijr: 15: 29)

"And verily We have made the Book of Moses, and We have proven it before that with the apostles, and We have given evidences of truth to Jesus son of Mary and We strengthened it with the Holy Spirit. people you deny and some people you kill? (Al Baqarah: 2:87)

"And if We were angels, we would have been men and, of course We would have doubted over them whether they doubted about themselves (Al An'aam: 6:9)

"So when I have perfected the scene and I breathed into him My spirit; then you should fall down prostrating to him." (Shaad: 38:72)

"Who has created the seven heavens in layers. You never see in the creation of the Most Gracious God anything that is not balanced. So look over and over again, do you see anything that is not balanced? (Al Mulk: 67: 3)

"O mankind, among us created you from a male and a female and made you into nations and tribes so that you may know each other. Indeed, the person you know best in the sight of Allah is the most pious among you. Allah is All-Knowing, All-Knowing (Al Hujuraat: 49:13)

"And verily We have created man and know what the heart whispers, and We are closer than his jugular vein (Qaf: 50:16)

In an effort to unmask Allah's secrets about whether Jesus celibate was contrary to Allah's law, the law of balance in the seven skys, the author of the foundation of deoxyribonucleic acid or deoxyribonucleic acid or the molecular structure of nucleic acids.

HYPOTHESIS

Here the author puts forward the hypothesis of Jesus celibate against Allah's law, the law of balance in the seven heavens, based on Deoxyribonucleic acid (DNA)

DEOXYRIBONUCLEIC ACID (DNA)

DNA is a repository of genetic information that has a double structure that form a double helix and which contains polynucleotide macromolecules arranged in repeatedly from nucleotide polymers. This nucleotide is composed of folate, a 5-carbon sugar and one of the nitrogenous bases. The nitrogenous bases are Guanine (G), Adenine(A), Cytocine(C) and Thymine (T). Guanine (G) is composed of 5 carbon atoms, 5 nitrogen atoms, 1 oxygen atom and 5 hydrogen atoms. Adenine(A) has 5 carbon atoms, 5 nitrogen atoms and 5 hydrogen atoms. Cytocine (C) contains 4 carbon atoms, 3 nitrogen atoms, 1 oxygen atom and 5 hydrogen atoms. Thymine (T) contains 5 carbon atoms, 2 nitrogen atoms, 2 oxygen atoms and 6 hydrogen atoms. Folate contains 1 phosphorus atom, 4 oxygen atoms and 2 hydrogen atoms. The 5-carbon sugar has 5 carbon atoms, 2 oxygen atoms and 8 hydrogen atoms.

Based on Deoxyribonucleic acid (DNA) humans are composed of 32.20% atoms carbon, 25.43% nitrogen atoms, 6.78% oxygen atoms and 35.59% hydrogen atoms.
