"Indeed, Allah commands you to convey your message to those who are entitled to receive it, and when you determine a law between people, so that you determine it fairly. Indeed, Allah gives you the best teaching. Indeed, Allah is All-Hearing, All-Seeing. (An Nisaa': 4 : 58)

In an effort to open the veil covering Allah's secrets about Islam which have become narrow because secular Muslims do not accept Allah's law as the source of state law, the author uses the basis of deoxyribonucleic acid.

#### **HYPOTHESES**
