*"Indeed, We have given you a glorious victory" (Al-Fath: 48: 1).*

*"...On this day I have perfected your religion for you, and I have completed My favor on you, and have I am pleased that Islam is a religion for you...(Al-Maidah: 5: 3).*

*"And you will judge the punishment of deeds between them according to what Allah has revealed, and do not follow their lusts. And be careful of them, so that they do not turn you away from some of what Allah has revealed to you. If they turn away, then know that Allah really wants to inflict calamity on them because of some of their sins. And indeed most people are wicked people (Al Maa'idah: 5: 49).*

In an effort to open the veil of Allah's secret about NII not follow the first Islamic state established by the Prophet Muhammad saw in Medina in 1 AH (622 AD), the author uses the basis of deoxyribonucleic acid.

## HYPOTHESES

Here the author proposes hypothesis NII not follow the first Islamic state established by the Prophet Muhammad saw in Medina in 1 AH (622 AD), based on Deoxyribonucleic acid (DNA)

## DEOXYRIBONUCLEIC ACID (DNA)
