*"...Indeed a mosque which was founded on the basis of piety (the Quba mosque), from the first day onwards is more worthy for you to pray in it..." (At-Taubah, 108).*

In my attempt to unmask the reasons for this, some people think that Islamic law can be applied as a whole in a secular Indonesian state based on Pancasila, based on deoxyribonucleic acid or deoxyribonucleic acid or the molecular structure of nucleic acids.

## HYPOTHESIS
