*"O you who believe, fear Allah and leave the rest of usury if you are believers. (Al Baqarah: 2: 278)*

*"And because they eat usury, when in fact they have been prohibited from it, and because they eat people's property in a vanity way. We have prepared for those who disbelieve among them a painful punishment. (An Nisaa ': 4: 4: 161)*

*"Those who eat usury cannot stand but stand like a person who has been possessed by a devil due to madness. Their situation is like that, is because they say, actually buying and selling is the same as usury, even though Allah has justified buying and selling and forbidding usury. Those who have received a prohibition from their Lord, then continue to stop, then for him what he took before and his business is with Allah. Whoever returns, then that person is the inhabitants of hell; they will remain therein (Al Baqarah: 2: 275)*

*"Indeed, zakat is only for the needy, the poor, administrators of zakat, converts whose hearts are persuaded, for slaves, people who are in debt, for the way of Allah and for those who are in journey, as a decree obligatory by Allah, and Allah is All-Knowing, All-Wise (At Tawbah: 9: 60)*

*"Indeed, We have sent down the Book to you with the truth, so that you may judge between humans and what Allah has revealed to you, and do not be a challenger, because of the treacherous (An Nisaa ': 4: 105)*

*"He is Allah, who made everything on earth for you and He willed the heavens, then made seven skys. And He is All-Knower of all things. (Al Baqarah: 2: 29)*

*"Who has created the seven skys in layers. You never see in the creation of God the Most Gracious something that is not balanced. So look again and again, do you see anything that is not balanced? (Al Mulk: 67: 3)*

*"And We did not create the skys and the earth and everything between them playing games (Al Anbiyaa ': 21: 16)*

*"God created the skys and the earth with rights. Indeed, in that there are signs of God's power for the believers (Al 'Ankabuut: 29: 44)*

In an effort to open the veil of Allah's secret cover about whether Saudi Arabia, Pakistan and Iran have followed the example of the first Islamic state built by the Prophet Muhammad in Medina, the author uses the basis of deoxyribonucleic acid.

## **HYPOTHESES**

Here the author proposes a hypothesis that Saudi Arabia, Pakistan and Iran do not follow the example of the first Islamic state built by the Prophet Muhammad in Medina, based on Deoxyribonucleic acid (DNA).

## **DEOXYRIBONUCLEIC ACID (DNA)**

DNA is a repository of genetic information that has a double structure form a double helix and which contain polynucleotide macromolecules arranged together repeatedly from the nucleotide polymer. This nucleotide is composed of folate, a 5 carbon sugar and one of the nitrogenous bases. Nitrogen bases are Guanine (G), Adenine(A), Cytocine(C) and Thymine (T).
