"Then He perfected and breathed into it His spirit and He made for you hearing, sight and hearts; you are very little grateful. (As Sajdah: 32: 9)

"So when I have perfected the event, and have breathed into it my spirit, then submit to it prostrating yourself (Al Hijr: 15: 29)

"And when the stars fall (At Takwîr: 81: 2)

"And they ask you about the spirit. Say: "The spirit belongs to the business of my Lord, and knowledge is not given to you but a little." (Al Israa ': 17: 85)
